## GETTING TO KNOW YOU

Which WOW member, who is not a founding member, has the oldest membership?

He is the subject of this months interview. **Andy Stanton** was recruited by **John Erickson** very shortly after he and **Jerry Hughes** organized the club. Andy says the meeting was upstairs at the Boys and Girls Club and he was one of five or six members. Andy was Vice President before taking the Raffle Chairman position.

Andy, a native Californian, grew up in Altadena and Pasadena, graduating from John Muir High School. Andy says photography was his passion at John Muir where he came within nine inches of besting the school record in the shot putt. He did take one semester of wood and metal shop but does not remember the wood class, something about cars and girls getting all the attention.

Enlisting in the U.S.Navy, he became a Aviation Photographer flying out of the Philippines for two and one half years and finished his tour aboard the cruiser, U.S.S. Rochester.

The woodworking bug bit him without his knowledge and in 1960 he bought a Shop Smith with a ton of accessories from Jack Carmichael at Battles. Andy says he did more woodwork on the Shop Smith in the first 10 years than he has since with a garage full of stand alone tools and almost all the power hand tools available.

Andy's working career started with Fuller Paint Company where he supervised the buying, designing, and printing of the company business forms giving him the graphic arts experience to start his own business. Omni Graphics, a graphic design and printing company was organized by Andy in 1970 and sold in 2000 when Andy retired.

Andy and his wife of 38 years, Hazel, have four sons, Rob, Paul, Michael and David.

Andy now enjoys fishing in the high Sierras, camping next to his favorite lake and riding his Harley Davidson. Andy's quote, "I have had a really great life and I've got a long time left".

## **SAFETY**

I am not an expert on safety but I do use a system that works for me. It is method of consciously recognizing and immediately eliminating hazards.

One thing I do know is safety rules do not prevent accidents. If safety rules prevented accidents, we would not have any accidents and yet we keep having them. Safety rules give us a secure I'm protected feeling because the safety rule is there. Will any method really keep people from having accidents and the simple answer is NO. But there are steps we can put into place and action that will **reduce our exposure to accidents**.

Now at this point I'd like to define **accident**. An accident is an unplanned event. Are all unplanned events accidents? I don't think so. Some accidents do not cause a loss but instead are called **serendipities**, a fortunate discovery. So need to expand on my definition. Accidents cause a loss. Loss of time, yeah; loss of money, ok; production, tools and equipment, yes again and body parts, no lets just say injuries. Is that all? No, but we will stop there.

So if the rules wont protect us why not? Human Nature. Yes, unfortunately we're human. It has been said that the human brain is the **BEST SAFETY DEVICE** and I would be inclined to agree if it just wasn't so easy to turn it **OFF**. We can turn it off when we see a pretty girl/ handsome man(your choice), listen to a song or just daydream about going home at the end of the day and now you have had an accident, so fast so fast so fast. **FACT**, the brain can only think of one thing at a time and if you are not tuned into preventing an accident when you are involved in a hazardous situation or hazardous act, you allowing **chance** to decide. OK what's the answer?

**Reduce your exposure.** Takes a lot of effort over a long period of time but it works. Requires you to **think and do**. Constantly being aware of exposure and reducing that exposure. The first thing you have to recognize is I'm not just talking about woodworking. Any and all activities including earthquakes present hazards that can be reduced. Driving is a total battle of exposure and reducing the exposure. Speed, intersections, driveways, tailgating and being tailgated, lane changes, pedestrians, trucks and **BIG TRUCKS**, kids and kids on bikes and skates and in other cars. Hopeless you think. Not really, just habit. Look for the most likely source of a problem and take the proper action immediately. The good news is you do this subconsciously and you just have to make it a conscious thought. Thirty days of real effort will make it a habit but don't stop at driving. It applies to what ever you are doing. When you see a tripping obstruction around the house, don't wait, as soon as you recognize it, correct it. While wood working look for anything that will fall on the floor, trip you or someone else, damage a project or tool, correct it immediately. This is the important step because it puts you in charge. And taking charge makes the exposure reduction work.

Stay Safe
